There are four key areas which will affect whether the development goes ahead:

Preserving the Settlement Gap: Inappropriate development, a threat to Wokingham's character.

Natural Environment: Destruction of Bottle Copse Local Wildlife Site, impact on protected species.

Loss of Rural Character: Hundreds of houses replacing green fields, impacting wildlife and views.

Road Safety: Increased traffic, dangerous junctions, and closure of Blagrove Lane.

Preserving the Wokingham-Barkham Settlement Gap:

- This land has never been identified for housing development and is excluded from the council's new Local Plan Update due to its agricultural and ecological value.
- Development in this location would compromise the distinct character of both Barkham and Wokingham.

Natural Environment:

- The development will destroy Bottle Copse, a designated Local Wildlife Site within a pristine ancient woodland. This site provides crucial habitat for bats, badgers, and birds, which will be severely impacted by the proposed road and its associated streetlights.
- The development will necessitate the felling of at least 167 mature trees and the uprooting of ancient hedgerows, destroying vital habitats and foraging grounds for numerous protected species.
- The destruction of this woodland will have a devastating impact on the local ecosystem.

Loss of Rural Character:

- This development will permanently remove valuable green space from the community, negatively impacting our quality of life.
- The open views from Viking Field will be obstructed by hundreds of new houses, transforming the area from a rural edge into a town-like setting.
- The development will isolate wildlife, preventing them from accessing Viking Field from the surrounding countryside.
- Blagrove Lane, one of the last remaining examples of an ancient rural lane in Wokingham, will be overwhelmed by increased traffic from the development.

Road Safety:

- The developer proposes closing Blagrove Lane to northbound traffic, forcing all traffic from the new estate onto a single southbound exit.
- To accommodate the increased traffic, the developer proposes a widened road junction outside Evendons School, posing a significant safety risk to children.
- Additionally, a new junction on Barkham Road will be located at a hazardous point near a bend and a hill.

The Inspector needs to understand how many local people value this open countryside.

Make your voice heard.

In 2013 the residents of Evendons Lane and the surrounding area gathered as a Residents Association to try to maintain the local environment and help ensure that any development on land surrounding Leslie Sears and Viking Field was appropriate. Now, Berkeley Homes has submitted a planning application to build approximately 350 homes beside Blagrove Lane within the unspoilt countryside.
